All potential PK Safety Hole Watch / Fire Watch personnel are equipped with the industry's best safety training, including the essential guidelines and training courses to perform the task at hand.

Both our classroom training and our hands-on field training are specifically tailored to our client, and each project. We will work with our client's' safety department prior to a project to obtain site-specific permits and procedures and incorporate this information into our specialized training.

Once the job begins, we utilize several exclusive operational processes ensuring the project runs safely and efficiently.





### **PK Safety Orientation**

PK Safety Hole Watch / Fire Watch personnel complete all orientation forms & documents with detailed directions to properly complete all needed information.



# **Hole Watch Training**

All PK Safety Hole Watch / Fire Watch personnel will go through OSHA approved confined space entry attendant training and the PK Safety confined space entry log, which includes the required permit policy of PK Safety.



### **Fire Watch Training**

Classroom training providing visual aids on the proper operation of portable fire extinguishers, as well as learning fire behaviors and fire science. All personnel are also trained on PK Safety HOTWORK permitting procedures.



#### **Live Burn Drill**

After completing the Fire Extinguisher training, all PK Safety Hole Watch / Fire Watch personnel will conduct a Live Burn Drill in full PPE and be required to extinguish the fire properly.

Air Monitoring

Through both classroom and hand on training, PK Safety Hole Watch / Fire Watch personnel learn about MX6 air monitors, in reference to OSHA and NFPA air monitoring standards.



# PK Safety Standard Operating Procedures

Standard Operating Procedures are implemented during training of all PK Safety Hole Watch / Fire Watch personnel to ensure proficiency in the policies of PK Safety.



### **Breathing Air Systems**

PK Safety Hole Watch / Fire Watch personnel are taught the importance of bottle watch duties along with how PK Safety's breathing air systems work. Hands on instruction for all PK Safety air trailers and 12 pack systems.



### Respiratory Protection and Usage

PK Safety Hole Watch / Fire Watch personnel are trained on how to use respirators, maintain the mask, and usage of the cartridges.



# **Confined Space Entry**

The dangers associated with confined space work in an industrial environment are taught to all PK Safety Hole Watch / Fire Watch personnel. They learn about the 6 entry points, and the three things that are used to determine what is a confined space., and what four things are required that make it a permit required confined space. OSHA 1910.146



# **Skill Evaluation**

Each PK Safety Hole Watch / Fire Watch employee will complete the skill evaluation portion of their training, individually. All stations will have an Operation's Manager, a Training Instructor, and / or a Crew Chief present to evaluate and give vital feedback, oneon-one, over each topic.



All PK Safety attendants perform light labor in addition to their safety attendant duties. This includes, but is not limited to, unit/BRM housekeeping, sweeping, trash pickup, hydration management, flagging/spotting, and rolling hoses. The overall efficiency is increased by continuous housekeeping during downtime and helps reduce the number of personnel and contractors onsite. Dedicated labor crews are available as well.



Our Project Managers and Supervisors are tenured employees and the best in the industry. They understand the unique skills needed to manage this line of work. Their job is to execute projects safely and proficiently, and to make sure that there are no delays in work, unless it is necessary to stop a job for safety issues. Our Field Leadership is client focused and an asset for both client personnel and PK Safety. The majority of our Field Leadership is also rescue-trained so the attention to detail for the overall safety of both our employees and all contractors onsite is at the forefront of their minds.

PK Safety Foremen are core employees, and their only responsibility is to manage Hole Watch / Fire Watch projects. Foremen are required to utilize the Foreman Work Execution Log, which tracks dispatch times, break times, lunches, and relief times of all our Hole Watch / Fire Watch personnel. "Work Checks", which are scheduled times that each Foreman must visit each employee to audit the job, are also tracked through this system.

Along with our Foremen, our PK Safety Supervisors and Field Leadership also play a vital role in safe and efficient project execution in addition to our training programs and operations processes.
